Purpose – Process Improvement

Features:

- Digital documentation
- TOM data includes:
 - Manufacturer, Part Number, Lot, Serial, Expiration
- Digital data survives sterilization, extreme temperatures, pressure and transport
- Digital data cannot be corrupted, overwritten or erased
- Additional digital data gathered over time, at critical points in supply chain to establish chain of custody
- Gain business intelligence throughout supply chain

Benefits:

- Visibility – alert, notify, share
 - Traceability – report, remove, repair
 - Action – analyze, conclude, learn

UDI & pedigree information stored digitally, dynamically updated at each point of custody, providing item level record keeping and visibility through to hospital, pharmacy, end use

Medical Device Service Providers – Sterilization Contractors

- Inventory process takes fraction of the time with TegoTags
 - Non line of sight inventorying of bottle, case, and pallets
 - Repeated before sterilization and after sterilization
- Digital data inside TegoTags on items, cartons and pallets survive sterilization processes
- For batch inventory, one TegoTag on a pallet carries a spreadsheet of information and details of the entire pallet, down to item level contents

Pharmaceutical Company – Requirements / Benefits

Digital ePedigree data and information gathered on the product

- TegoTags store data at fingertips

Visibility - chain of custody information at the product level

Authenticated products means counterfeits are easily identified and removed anywhere in the supply chain

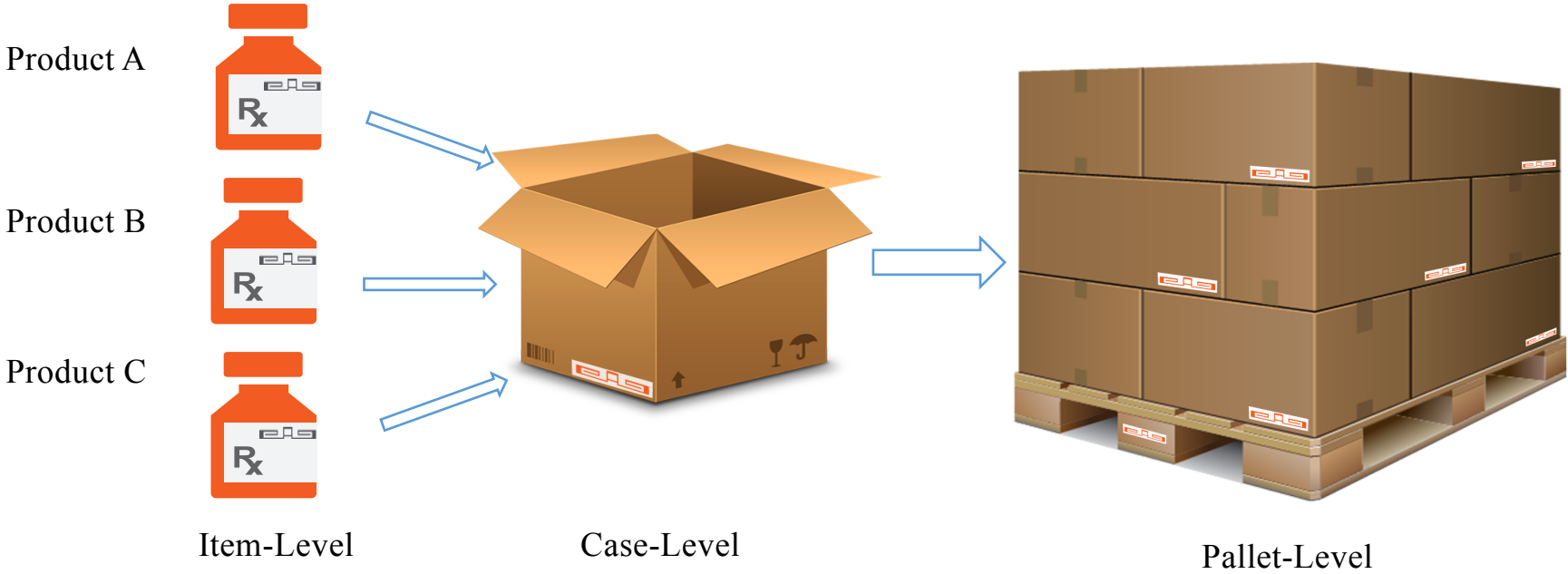
Additional certificates can be added by qualified vendors as product moves downstream
